### **EJTF ACTIVITIES**

### EARTH DAY

On Earth Day (4/22/2019), EJTF Chair Nancy Griffeth joined with a number of environmental groups in an Earth Day press conference at the State House Annex in Trenton (see photo). The groups demanded that the state Legislature and Governor move forward on a strong environmental agenda for New Jersey, issuing a comprehensive press release that emphasized the climate crisis that's getting worse. "Sea levels are rising and we have more extreme weather. New Jersey residents worry about climate damage and the potential impact of proposed fossil fuel power plants and pipelines. What's even more alarming to residents and environmental groups is the lack of urgency the Legislature and Governor show when it comes to reducing greenhouse gases (GHG's) and moving forward with renewable energy."

At the press conference, Nancy Griffeth stated that: "Governor Murphy himself has set the state a goal of 100% renewable energy by 2050. The current arc of development of fossil fuel infrastructure will prevent reaching this goal. The governor reminds me of a riddle: Six frogs are sitting on a lily pad. One decides to jump. How many are left? Six — deciding to jump is not the same as doing it. And declaring a goal of 100% renewable energy without taking the right steps to get there won't get us there. Investing billions of dollars in infrastructure that will last for 30 years will prevent development

of infrastructure for solar, wind, and storage that can actually get us to 100% renewable energy. Setting a goal is not enough; he has to take action to reach the goal."

### **UU FAITHACTION NJ SPRING PLENARY**

EJTF Members attended the Spring Plenary meeting of UU FaithAction in Montclair on April 13, 2019. At the meeting, the Environmental Justice Task Force (EJTF) reviewed the year's work on addressing climate change and lead in New Jersey's drinking water. We were actively involved in helping to define the rules for the Community Solar Pilot Project and have recently been working with the Board of Public Utilities (BPU) to publicize the pilot in low income communities. We also commented on the Energy Master Plan (EMP) and are looking for the draft EMP, which should appear in early June, for further comments. We are among the founding members of EmpowerNJ, the coalition demanding that Governor Murphy declare a moratorium on fossil fuel infrastructure and sponsoring "Moratorium Mondays." Also, we are signing on to Bill Potter's petitions to the BPU and the New Jersey Department of Environmental Protection (DEP) for reconsideration of their permits for various pipelines. In addition, we are actively supporting the electric vehicle bills S2252/A4819, while pushing for a more aggressive transition to electric school buses and transit buses.

At the Spring Plenary meeting, Amy Goldsmith (Clean Water Action and the steering committee of EmpowerNJ) discussed the need for halting development of fossil fuel infrastructure in New Jersey. Ray Nichols (Vice Chair of the EJTF) discussed making comments on the Northeast Supply Enhancement to the DEP, which were subsequently written and submitted on May 2, 2019, and Bill Potter (former Chair of the EJTF) described the rationale for petitioning the BPU and DEP to reconsider permits for pipelines in addition to demanding that Gov. Murphy declare a moratorium.

### TESTIMONY AT NJ LEGISLATIVE SESSION

EJTF member Lyle Rawlings (President, Mid-Atlantic Solar & Storage Industries Association (MSSIA); President & CEO, Advanced Solar Products) testified at the 5/16/2019 Senate Environment and Energy Committee hearing on S3681, which requires all electricity in New Jersey by 2050 to come from carbon-free sources, and S 3215, which require state agencies to use the 20-year time horizon in assessing climate pollutants instead of the 100-year time horizon that had been being used. ### **UPDATE ON EJTF KEY ISSUES FOR 2019:**

### 1) Fighting against fossil fuel infrastructure

We are working on actions related to achieving a moratorium on new fossil fuel infrastructure in NJ. We have joined Empower NJ - Twitter hashtag, #empowernj - a coalition of environmental groups, to demand that Governor Murphy declare a moratorium on building fossil fuel infrastructure. We are asking our members to contact the governor, especially on "Moratorium Mondays" (see above), to write letters to print and on-line news sources, to attend demonstrations against new pipelines and power plants, and to organize educational events in their congregations and in our municipalities.

In addition, we are signing on to EJTF member Bill Potter's petitions to the Board of Public Utilities (BPU) and the New Jersey Department of Environmental Protection (DEP) for reconsideration of their permits for various pipelines

# 2) Reducing Green House Gas (GHG) emissions from transportation

## - Electric Vehicles (EV's)

**Legislation:** For electrification of New Jersey's transportation sector, we are supporting New Jersey Senate Bill 2252/ Assembly Bill 4819, which "establishes goals, initiatives, and programs to encourage and support use of plug-in electric vehicles," with some changes, for example, to include electrifying school buses and improving public transportation in New Jersey.

A position paper on electrification of vehicles is in progress.

# Be Aware: Growing Marijuana Can Increase Your Carbon Footprint



As UUFANJ advocates for both 100% renewable energy and legalization of marijuana in New Jersey, it's worth being aware of the potential conflict between those two goals.

It turns out that in states where marijuana has been legalized, the "carbon footprint" of growing operations is through the roof! One study showed that 3% of all California energy use was for growing pot; Denver's Department of Public Health and Environment reported that the energy-hungry plants soak up nearly 4 percent of the city's total electricity use.

The reason is that production facilities that grow marijuana plants indoors use high intensity lighting and cooling systems, often running 24/7. The good news is that as the problem has been recognized, efforts are underway to introduce energy efficiency measures, but with production demand on the rise the overall energy use is still increasing. In Massachusetts regulations set strict limits -- some of the toughest in the nation -- on the amount of energy growers can use to raise their plants.

As UUFANJ moves forward with advocacy on both issues, let's learn from these experiences of other states and consider adopting some of their solutions.

• **OP-ED:** Lawmakers Should Pass Bill Supporting Electrify NJ Agenda — Per Rev. Ronald Tuff (GreenFaith) and Rev. Bryant Ali (Newark's GreenFaith Circle), bill S-2252/A-4819 embraces changes vitally important to NJ cities, including accelerating the deployment of electric vehicles and transportation infrastructure across the state, and moving NJ Transit to replace its heavily polluting bus fleet with a new generation of electric buses. These changes are vitally important to New Jersey's cities, where air pollution and climate change threaten public health and safety. However, the legislation must prioritize reducing air pollution and creating jobs in our cities:

### FOSSIL FUEL INFRASTRUCTURE

- State's New-Look Energy Plan Is Delayed, Now Expected in December The Murphy administration's overhaul of New Jersey's Energy Master Plan is being put off while urgent energy issues are being dealt with. - New Jersey Wants Trump to Scrap Plans to Drill in Atlantic, Arctic Oceans In a letter to the secretary of the U.S. Department of Interior, New Jersey's congressional delegation urged the agency to permanently withdraw plans to conduct oil and gas exploration in the Atlantic and Arctic oceans, a proposal that has triggered wide bipartisan opposition up and down the Eastern Seaboard. The bipartisan letter from the 12-member delegation from New Jersey came on the heels of the Department of Interior's announcement it would stall plans to expand drilling and exploration in the two oceans following a recent federal court ruling in Alaska:

• N.J. AG Grewal applauds Trump Administration Move to Abandon Offshore Drilling Plans - NJ Attorney General Gurbir Grewal praised the decision, saying the move could have harmed the environment as well as the state's significant tourism industry. The offshore drilling plan was scrapped after a setback in a federal court in Alaska, as well as widespread bipartisan opposition. NJ filed two lawsuits against the federal government aimed at stopping the Trump administration's plan to expand offshore drilling for oil and gas and finding out why only Florida was given an exemption from the drilling plans. - Pipeline Planned for Raritan Bay is a Safety Risk That Keeps Us All Dependent on Dirty Fossil Fuels, Environmentalist Says As New Jersey shifts energy policy to focus on renewable sources like wind and solar, and away from fossil fuels, proposals still come forward to build "pipelines to the past" that serve no good purpose and take vital dollars away from infrastructure investments in today's emerging energy sources. One example is the proposed Northeast Supply Enhancement (NESE) Project being pushed by Williams-Transco, an Oklahoma-based gas pipeline company. - FERC Gives Approval for Transco Pipeline's Northeast Extension The Federal Energy Regulatory Commission (FERC) authorized the expansion of the existing Transco natural gas pipeline to serve New York markets. The expansion, called the Northeast Supply Enhancement project, will provide 400,000 dekatherms per day of additional natural gas supply to National Grid the largest distributor of natural gas in the northeast. - Major Victory for Climate Campaigners as NY Gov. Cuomo Rejects 'Dangerous' Williams Pipeline Grassroots climate campaigners in NY celebrated a major victory on 5/15/2019 as Gov. Andrew Cuomo blocked the construction of a \$1 billion pipeline which would have carried fracked gas from NJ to LI. • Newark Begins to Treat Water With New Chemical Expected to Lower Lead Levels - On 5/7/2019, Newark began a program to treat its water with a new chemical that is expected to reduce lead levels. - **3M, DuPont Refuse to Pay for New Jersey Chemical Cleanup** Chemours Co., 3M Co. and DuPont are taking a stand against what one company called an "unprecedented" New Jersey order, saying they won't pay for a statewide investigation of fluorinated chemical contamination. They asserted they aren't responsible under the state's Spill Compensation and Control Act. The companies said they could not comply with a DEP directive to pay for the investigation and cleanup of PFAS because the order was too broad to be effective. The companies also said it would be "wildly expensive" to even assess the costs of the cleanup sought by the directive, which the DEP said was the first of its kind in the nation:

• **SEC Filing: PSEG Yet to Decide About Equity Stake in Offshore-Wind Project** - The BPU is reviewing applications for approval of plans to build an initial cluster of wind farms, to generate as much as 1.1 gigawatts of electricity. Public Service Enterprise Group appears to be keeping its options open on how much it will invest in the state's ambitious efforts to be a leader in the offshore-wind industry that's developing up and down the Eastern Seaboard:

- Lawmakers Want to Know How Much Customers Will Pay to Fund Clean Energy Back-of-the-envelope estimates indicate Murphy's clean-energy agenda will easily cost more than \$15 billion. Legislators are beginning to worry about just how much it will cost utility customers to finance the Murphy administration's ambitious clean-energy agenda. At a wide-ranging hearing on 4/25/2019, top officials from the administration laid out what actions they are taking to transform New Jersey into a 100 percent clean-energy economy by 2050:

- Lawmakers Embrace Goal Of A Fossil-fuel Free New Jersey By 2050 Business groups say a bill approved by committee moves too fast, while advocates say concrete steps are needed to stem global warming. On 5/16/2019, the state took a first, if only tentative, step toward phasing out its reliance on fossil fuels an action that nevertheless drew opposition from business lobbyists and flak from climate-change activists who argued it does not go far enough in dealing with the global-warming crisis. ### **CLIMATE CHANGE**

- Three Governors Pledge to Cooperate on Delaware River Basin Environment The governors of NJ, PA and DE promised on 5/16/2019 to work together to preserve the natural resources of the Delaware River Basin but said there is only so much they can do without more federal money. - New Sense of Urgency in State's Mission to Reduce Global Warming NJ needs to step up efforts to drive down greenhouse gas emissions, including weighing whether to incorporate the social costs of carbon into an array of government decisions, lawmakers were told during a rare joint hearing of the Legislature's two environmental committees on 4/25/2019. Jeanne Herb, executive director of environmental analysis and communications group at Rutgers University's Bloustein School of Planning, stated "To achieve the state's 2050 limit, we need to reduce emissions by 75 percent below today's levels." NJ still does not have a statewide climate change vulnerability assessment to identify people, places, communities and natural resources most at risk right now:

- In Battle To Counteract Climate Change, A New Reason To Hug Trees Roughly 2.5 million metric tons of the carbon emissions that cause global warming are stored in New Jersey's forests. That issue is attracting the attention of legislators who are looking at how they can advance climate-change adaption policies in New Jersey, a coastal state particularly vulnerable to rising sea levels and extreme storm events. In March, the Corps proposed measures including sea walls and storm-surge barriers, as well as nature-based programs like building up coastal marshes, as ways of keeping ocean waters out of vulnerable back-bay communities. The New Jersey Back Bays Coastal Storm Risk Management Feasibility Study Interim Report invited but did not publish reactions from stakeholders including municipalities, other government agencies, and environmental groups:

- Carbon Pricing Reaches U.S. House's Main Tax-Writing Committee Less than a year ago, the House voted to denounce carbon taxes. Now, it's discussing a carbon pricing plan supported by some Republican Party luminaries. A coalition of business and environmental groups, working with the support of some major oil companies, took a carbon pricing plan to the U.S. House's main tax-writing committee on 5/15/2019. It was the Ways and Means Committee's first climate-related hearing in a dozen years, and members of both parties treated the topic with kid gloves. For the panel to be talking at all about climate change is momentous—it signals that carbon taxing has moved into the realm of the possible. But members were cautious to avoid endorsing any specific idea:

• Another Push for NJ Ban on Plastic Bags and, Maybe, Paper Bags Too - With many New Jersey municipalities already having passed ordinances to reduce the use of plastic bags, straws, and Styrofoam containers, move is on for a statewide policy. The ban is attracting increasing support among residents, businesses and even municipal governments since Gov. Phil Murphy last summer vetoed a bill banning plastic bags while imposing a nickel fee on paper bags. (The governor vetoed it because he said he wanted a stronger version.) Since then, more than 50 New Jersey municipalities have passed ordinances. - **Huge Win for PSEG as Reluctant BPU Approves Nuclear Subsidies** 'The board is being directed to pay a ransom,' said Commissioner Bob Gordon. Upendra Chivukula was the only commissioner to vote 'no'. A deeply conflicted Board of Public Utilities yesterday approved \$300 million a year in subsidies to the owners of New Jersey's three nuclear power plants, ignoring three separate analyses that found the units profitable and in no danger of closing. • Rate Counsel Challenges Nuclear Subsidy in Appellate Court - The amount of the surcharge, which PSEG helped determine, is likely to be a linchpin in the proceedings. As expected, Rate Counsel Stefanie Brand on 5/14/2019 challenged the award of \$300 million in ratepayer subsidies to keep PSEG Power's three nuclear power plants open in South Jersey in a case filed with the New Jersey Appellate Division. The subsidies, dubbed zero-emission certificates, were given to the plants last month by the

- state Board of Public Utilities, a decision that ignored the recommendations of Rate Counsel, the BPU's own staff, and an outside consultant retained by the BPU. All three concluded the plants failed to meet the financial threshold to qualify for the subsidy. - Potential Identified for Big Energy Efficiencies in NJ An analysis suggests a 20 percent cut in electricity use and an 11 percent cut in gas use is possible in NJ, with achievable net benefit savings of \$14 billion due to new energy efficiency programs. The study by Optimal Energy is expected to form the basic outline of a more comprehensive statewide policy for reducing energy use. The Murphy administration has identified slashing energy consumption in New Jersey as a key component of its overall goal of transforming the state to 100-percent clean energy by 2050:

- New Rule Could Cost Utility Customers Millions, Rate Counsel Challenges The New Jersey Division of Rate Counsel is challenging a new rule that it says could cost utility customer millions, if not hundreds of millions, of dollars in future rate cases. The regulation, adopted by the state Board of Public Utilities earlier this year, deals with how utilities use the savings they achieve when they file consolidated tax returns with parent companies and affiliates. (All of the state's utilities are owned as subsidiaries by parent companies.) The regulation changes how certain savings are split, now giving the lion's share to utilities at the expense of customers:

- **BPU Considers Greater Energy Assistance for Poor Residents** Subsidies already add a significant amount to customer bills, a situation likely to worsen as utilities move to strengthen the power grid, and roll out infrastructure for electric cars. The state is examining whether to expand its popular low-income energy-assistance program, a fund that ensures eligible recipients pay no more than 6 percent of household income to electric and gas bills.
