# **EJTF ACTIVITIES (continued)**

• At the 6/23/2022 "March and Rally for Clean Air and Climate Justice," convened by the EmpowerNJ coalition (of which EJTF is a member), EJTF members and other Unitarian Universalists (UUs) joined hundreds of community and climate activists and environmental justice leaders, demanding that Gov. Murphy deny permits for major new fossil fuel projects. They gathered at the Patriots Theater at the War Memorial before marching to the Statehouse Annex, where speakers from frontline communities talked about the threats they are facing from new projects. They pointed out that, while the state's environmental justice law is an important step, it is not being applied to the current proposals, including a new fracked gas power plant at the Passaic Valley Sewerage Commission (PVSC) treatment plant in Newark. ## "Tell NJDEP: No Fracked Gas Compressor Expansion - Rally & Public Hearing" In-person

### Thursday, August 4, 2022: rally at 5:30 p.m.; public hearing at 6:00 p.m. Sussex County Technical School, 105 N. Church Rd, Sparta, NJ 07871

On 8/4/2022, the NJ Department of Environmental Protection (DEP) will hold the only planned public hearing on the final pending permit required for the North Jersey Compressor expansion proposal. Tennessee Gas Pipeline Company (TGP) plans to triple the size of its fracked gas compressor station in Wantage and build a new one in West Milford.

A rally is to be held before the public hearing, "to call on Gov. Murphy to live up to his climate and environmental commitments and stop this dangerous and unnecessary project." The organizers will be in touch with all those who RSVP, to share talking points to help prepare for making comments at the hearing. #### U.S. Bureau of Ocean Energy Management (BOEM) "Ocean Wind 1 Project" Draft Environmental Impact Statement Comments due August 8, 2022

The U.S. Bureau of Ocean Energy Management (BOEM) has released the Draft Environmental Impact Statement (DEIS) on the proposed Ocean Wind 1 project, Ørsted's 1,100-megawatt offshore wind farm off the coast of NJ. The BOEM held three virtual public hearings on the DEIS; **the public comment period closes at 12:59 p.m. on August 8, 2022**. #### Comments Due on NJDEP proposed implementing regulations for NJ's Environmental Justice Law September 4, 2022

These are the regulations needed in order for the NJ Department of Environmental Protection (DEP) to implement the landmark Environmental Justice Law enacted by NJ in 2020. "The proposed rule will require certain facilities seeking certain permits in overburdened communities to prepare an environmental justice impact statement and conduct a public hearing to ensure meaningful public participation ... the Department will apply permit conditions where necessary ..."

This comes at a time when recent rulings by the Supreme Court have frayed he fabric of society and put our environmental rights and future into jeopardy. As Founder, Maya van Rossum asserted, a "Green Amendment" can be a viable and powerful counter that explicitly solidifies the government's obligation to protect our right to a clean and healthy environment, guaranteeing it for current and future generations." #### "New Jersey's Whole House Pilot Program" - Video of Webinar

In May 2018, Gov. Murphy signed into law the Clean Energy Act, (CEA), which set forth ambitious goals to advance energy efficiency (EE) and other clean energy efforts. In the years following passage of the CEA, state agencies, public utility companies, and a broad range of stakeholders worked collaboratively to review and consider options and best practices on a myriad of topics related to EE. Many stakeholders expressed support for an approach that would integrate health and safety measures with EE upgrades. The Whole House Pilot Program ("WHPP") intends to take a "whole house" approach to addressing health and safety concerns and implementing EE measures in single- and multi-family residences occupied by low- to moderate-income residents. This pilot will also test an integrated, statewide strategy that streamlines and leverages existing resources, programs, and funding streams from multiple sources, including Federal, State, and Local governments, non-government organizations, and non-profit organizations. - NJEDA to Expand Electric Vehicle Voucher Program Statewide The New Jersey Economic Development Authority (NJEDA) has announced "the expansion of the New Jersey Zero Emission Incentive Program (NJ ZIP) to support businesses and institutions statewide that are purchasing new, zero-emission medium- and heavy-duty vehicles operating in New Jersey... the NJEDA's Board approved the \$45 million expansion, through its Regional Greenhouse Gas Initiative (RGGI) allocation, doubling the amount of funding dedicated to the program. In addition to increased funding for the program, the NJEDA Board also approved two major eligibility changes from the earlier phase expanding eligibility to include heavy-duty vehicle classes, and expanding statewide, beyond the four pilot communities in the first phase... - NJ among 16 States Suing US Postal Service over Lack of Electric Vehicles NJ joined 15 other states to sue the U.S. Postal Service (USPS) over its plan to replace \$165,000 delivery trucks with only 10% of the replacements slated to be electric vehicles in the current contract. The lawsuit, along with two others filed by environmental advocate groups, cites the inadequacy of the environmental review performed by the USPS under the National Environmental Policy Act (NEPA). #### Food Access-related Legislation Signed by Gov. Murphy

S2921/A4365 - This bill revises certain requirements of the Food Desert Relief Program, through which the New Jersey Economic Development Authority (EDA) provides incentives for the establishment of supermarkets and grocery stores within food desert communities.

A2364/S2017 - This bill would appropriate from the General Fund to the Department of Human Services the sum of \$813,000. The bill requires the Department of Human Services to use the funds to implement the use of electronic benefits transfer cards by persons participating in the Senior Farmers' Market Nutrition Program.

- This Tree Planting Initiative Is Promoting Sustainability, Togetherness In Newark This article describes the "Renaissance Trees Program," an initiative of the NJ Tree Foundation (of which EJTF Co-Chair Peggy Middaugh is a Trustee), which is "a community-based reforestation effort that began in 2006 in the City of Newark... Created to increase the tree canopy, improve the environment, and enhance the quality of life... the Renaissance Trees Program has planted 3,966 trees. More than 21,974 square feet of concrete has been removed, improving stormwater management and promoting a healthier community forest." These violations concern the Biological Opinions issued to the Army Corps of Engineers for the New Jersey Wind Port project and the Edgemoor Container Port project. If permitted by the Army Corps, these commercial ports could threaten the continued existence of the Delaware River Estuary's genetically unique population of Atlantic sturgeon. ## LEAD REDUCTION IN HOUSEHOLDS

 New Law Requires State to Remediate Lead-Burdened Homes in NJ (5-minute news video) -On 7/22/2022, NJ's law addressing lead paint in rental dwellings went into effect (the NJ guidance document is available here: <u>https://nj.gov/dca/divisions/codes/resources/pdfs/lead\_based\_paint\_guide\_rental\_dwellings.pdf</u>). It requires that rental properties subject to the new law (i.e., one- and two-family residential rental homes built before 1978) must be inspected upon tenant turnover or within two years if there is no tenant turnover, but no later than July 22, 2024. #### **Update on Liberty State Park Legislation**

Unlike the previous "Liberty State Park Protection Act," it did not protect the Park from privatization and would open it to commercial development, and it did not call for protection of any specific areas such as Caven Point. The new bill was passed and approved by Gov. Murphy; however, prior to its passage, it was amended to delete "economic" and "business opportunities" from the list of goals and to add "cultural" to the goals. Further, specifics related to informing and involving the public as planning progresses over time were added, panel membership was increased from 17 to 23, and funding was decreased from \$250 million to \$50 million. It should be noted that, since passage of this legislation, a bill has been introduced (S2956/A4468) that would "designate and preserve Caven Point Peninsula... as natural habitat."
