Join the SubjectToClimate Teacher Task Force!

Michael Skelly has represented EJTF in support of the initiative to teach climate change in NJ Schools. In 2020 NJ became the first state in the country to teach climate change in all grade levels K through 12 and all subjects in public schools. Now, EJTF is spreading the word and making connections to expand these climate education programs in NJ.

The SubjectToClimate Task Force members will be paid \$21/hour; the work schedule is remote and is flexible. Task Force members must be passionate about the mission, be able to create original content, have at least two years of formal teaching experience or two years in an educator role (e.g., in informal settings such as parks, zoos, aquariums, gardens, or community leadership); and have access to an Internet connection and a laptop or desktop computer. Auxiliary requirements include: knowledge of climate change topics; the ability to balance working independently and collaboratively; experience working in schools from overburdened and low-income communities (especially Title I schools); work experience in a variety of teaching positions including curriculum development; participation in hands-on, project-based, and/or problem-based learning; and experience with NJ Learning Standards

Comments Due 9/6/2023 on NJBPU - Technical Conference on Reducing Emissions in the Natural Gas Sector

On 2/15/2023, Gov. Murphy signed Executive Order 317, directing the NJ Board of Public Utilities (BPU) to develop recommendations regarding how the natural gas industry can reduce greenhouse gas (GHG) emissions to meet the Governor's goal of 50 percent reduction in GHG emissions below 2006 levels by 2030. Executive Order 317 further directs the BPU to engage with stakeholders regarding the development of natural gas utility plans consistent with the Governor's directive. The BPU held a Technical Conference to "begin the formal stakeholder engagement in the Future of the Natural Gas Utility Proceeding, as well as frame the policy and technical considerations that underpin this planning process." Public Hearing: NJDEP Rulemaking -Advanced Clean Cars II Program 9/21/2023, 9:30 a.m. - Virtual

"The NJ Department of Environmental Protection (DEP) is proposing the promulgation of new Air Pollution Control rules....The primary component of this rulemaking is the incorporation by reference of California's Advanced Clean Cars II (ACC II) regulation, which will require manufacturers of passenger cars and light-duty trucks to meet an annual zero-emission vehicle (ZEV) requirement intended to increase the percentage of ZEVs sold in New Jersey that meet the minimum technical requirements. Additionally, the ACC II regulation includes more stringent multi-pollutant exhaust emission standards that manufacturers of internal combustion engine passenger cars, light-duty trucks, and medium-duty vehicles must meet....A public hearing concerning the proposal will be conducted virtually via the Department's video conferencing software on September 21, 2023 at 9:30 A.M." 22 Attorneys General, Including Pa. And N.J., Oppose 3M Settlement Over Water Systems Contamination With 'Forever Chemicals'

The attorneys general of NJ, PA, 17 other states, Washington, D.C., and two territories filed a "Memorandum of Law in Support of the Sovereigns' Motion to Intervene," (available here: https://oag.ca.gov/system/files/attachments/pressdocs/Motion%20to%20Intervene.pdf) with the U.S. District Court, related to the City of Camden, et al. v. 3M Company \$10.3 billion settlement proposal over contamination of U.S. public drinking water systems with PFAS ("forever chemicals"). "...[T]he attorneys general said it would force nearly all public water providers nationwide to participate unless they withdraw individually - even those that haven't filed suits or tested for PFAS....they would have to make their opt-out decisions without knowing how much they would actually receive and, in many cases, before knowing the extent of contamination in their water supplies and the cost of remediating it....[and] the proposed deal would shift liability from 3M to water suppliers that don't opt out....[which] could enable the company to seek compensation from providers if sued over cancer or other illnesses in PFAS-affected communities." https://whyv.org/articles/pa-ni-attornevs-generaloppose-3m-settlement-water-systems-contaminationforever-chemicals/

ENERGY EFFICIENCY

NJ Moves to Cut Fossil Fuels From Homes, Businesses

The NJ Board of Public Utilities ("Board") approved its framework for the second 3-year cycle of energy efficiency programs, including decarbonization start-up programs for buildings. It mandates electric utilities, and encourages gas utilities, to begin offering incentives for voluntary replacement of gas stoves and heaters with electric ones, providing funding of up to \$350 million over 3 years for various aspects of the program. This was the program that the BPU pulled from the agenda at a previous meeting; it was opposed by the NJ Division of Rate Counsel, legislators and some business lobbvists (see

One issue cited was that the BPU does not have the authority to set environmental policy or to regulate carbon emissions, which would be a result of implementing this plan. Toms River Cleanup Deal Nets More Money, Land

As described in this article, "New Jersey finalized a settlement with the chemical company BASF to compensate the state for damage to natural resources as a result of chemical leaks at Toms River by the company's predecessor, Ciba-Geigy. BASF will pay more money, designate more land and spend more time restoring formerly polluted lands at Toms River than was first proposed by the state, the Department of Environmental Protection [DEP] said....The DEP modified its original plan, proposed late last year, in response to public comments made as part of the settlement process. As a result, BASF will pay \$500,000 for damage to natural resources and project oversight costs, up from an original \$100,000." The DEP has a webpage dedicated to the settlement, available here:
