You're receiving this letter because we have you listed as a UUFANJ contact for religious education at your congregation. Please let us know if there are others in your congregation who should receive this. We are reaching out because we need your help. The State of New Jersey adopted updated standards for comprehensive sexuality education in 2020. Since that time right wing extremists have seized upon this issue, making false claims about the new standards, and promoting the idea that some teachers are using the new standards to "groom" and sexualize children, promote gender "confusion", etc.

These accusations are patently false, but have started to take hold around the state. Many of these efforts are supported and funded by organizations like Jersey Rising, Moms for Liberty & Garden State Families. This campaign is yet another case of mis/disinformation being used to create discord, advance extremist agendas and promote hate.

As Unitarian Universalists we have a long and proud history of leadership in promoting comprehensive sexuality education for people of all ages. Beginning with About Your Sexuality (AYS), and then with the development & implementation of the Our Whole Lives curriculum, our UU children and youth have benefited greatly from sexuality education that is fact based, non-judgemental, and life affirming. UUs, along with the United Church of Christ (our OWL partners), have deep experience and expertise in the area of comprehensive sex ed.
